


TITLE

Design of concrete for large dams of all types and influence of age on concrete properties.

COMMENTS

The papers should deal with:

- a) the selection of concrete for all types of large dams needed to meet diverse (various) sites and climatic conditions;
- b) the specification in detail of concrete and the variations with age of the main properties of concrete such as strength, elasticity, watertightness, frost resistance and thermal properties;
- c) the consideration of factors which give to cracking and the behaviour in general of concrete under combined loading (combined compressive and tensile strength, etc.
