Maximum length for papers is 10,000 words; for notes, 3,500 words; for discussions, 1,250 words. Multiple submissions are not accepted for review. Indicate division and, if applicable, committee to which material is being submitted. The use of SI units is preferred; if other units are used, SI equivalents must also be given. Write or phone the Journals Department for *ASCE Authors' Guide to Journals, Books, and Reference Publications* for complete instructions for manuscript preparation.

Reprints for authors can be ordered prior to publication using reprint order forms provided by the Editorial Department.
